RECENT ACTIVITIES

As we approach the annual general meeting to be held at our annual conference in late May, the Nominating Committee has been busy with ensuring that all Board positions will

have a nominee for the coming year. You will soon receive a copy of the committee's report from our National Office. Members should be aware that, as per Article 8.10 of our bylaws, a number of Board positions are contestable should that be the will of a sufficient number of members.

The Board's adhoc bylaw review committee continues to make progress on the review required as part of our filing of Articles of Continuance under the Canada Not-for-profit Corporations Act with Industry Canada. This committee is now being chaired by our Honorary Treasurer, Dan Dankewich.

UPCOMING ACTIVITIES

I am planning on attending three conference events near to the end of my term as President, including the Hydrotechnical Division's 21st conference in Banff, the EIC climate change conference in Montreal, and of course our own annual conference also being held in Montreal.
